Remaining Questions to be Answered Received from Gail Ortiz

How many employees is LSSI committed to? Answer: According to the City's contract with LSSI for library administration, 58.5 "full time equivalent employees" (FTE's) will be hired for the three city libraries. The 58.5 FTE's will equate to approximately 85 total employees to account for full and part time employees. Through conversations with the L.A. County Library, we believe 85 employees is roughly the same number of staff currently employed for the three local libraries.

How many jobs lost overall? Answer: No decrease in the number of jobs is expected. It is expected that the number of employees will be similar.

Are there minutes for Ad hoc library committee meetings? Answer: No, there are no minutes for the ad hoc committee meetings. State Law does not require that agenda be prepared or minutes kept for these meetings.

That city staff serves on Library Ad-hoc committee? Answer: The Library Ad Hoc Committee consists of Mayor McLean and Mayor Pro Tem Ender. Staff does not serve on the Library Ad Hoc Committee. Various staff members attend meetings of the Library Ad Hoc Committee, depending upon what is on the agenda. Typically, the city manager, assistant city manager and deputy city manager serve as staff for the Library Ad Hoc Committee.
