The time to act is NOW. The currently proposed SANITATION DISTRICT FEE

INCREASE, if passed, will be the largest single **TAX INCREASE** in the history of Santa Clarita. It will cause you to pay, a minimum, of **\$564 per year** on your annual property tax bill by 2015 and that is just the start. This **300%** increase will be voted on Tuesday May 26 at 3:30 PM at a Public Meeting.

Mayor Frank Ferry, Council Member Laurene Weste and a representative of the County of Los Angeles will be making the decision. This proposed action is not based on validated scientific data and was created by the Sanitation District without consideration of alternate solutions. If you are as outraged as I am, here is what you can do. Please send a letter, phone or email Mayor Ferry <u>fferry@santa-clarita.com</u> and Council Member Weste <u>lweste@santa-clarita.com</u>) Tell them that you are opposed to the proposed Sanitation District fee increase. Ask them to VOTE NO on this fee increase. Tell them to send the Sanitation District back to validate their information and propose alternate solutions for the issue of reducing Chloride levels in our river. The time to act is NOW.
