Spouses and domestic partners may each contribute the maximum, even if their account is controlled by the same person, as long as they both sign the check, credit card authorization form, or accompanying letter. We may not deposit your check or credit card payment without your name, street address, occupation and employer, and may not accept cash, cashiers checks or money orders. A business and its owner, partnerships with the same general partner, and other affiliated entities are subject to a single, combined limit of \$6,500 per election. We may not accept contributions which have been reimbursed by another person unless you inform us of the true source of the contribution; we may also not accept contributions from registered state lobbyists, foreign nationals, persons who are negotiating contracts with the City and County of San Francisco subject to the District Attorney's approval or who have received such a San Francisco contract within the last six months, or from their directors, officers or owners. *Recurring contributions are automatically made on a monthly basis*
